1. Person-specific information concerning data protection can be requested at any time in writing from the Management Board.

Your personal data is processed for the implementation of the membership ratio in the Turn-Team Sickingen e.V. and as well in the context of participation in the sports business of Turngau Sickingen e.V. and Pfälzer Turnerbund e.V. - Participants of our "Gymwelt" must also be reported to AachenMünchener Versicherung AG for actuarial reasons.
3. The data are collected directly during the admission procedure.
4. The data concerning your person will be forwarded to the national association for purposes of licensing and within the framework of the sports company.
5. Your bank details will be forwarded to Kreissparkasse Kaiserslautern together with your name, intended purpose and the amount of the claim for the purpose of direct debit collection.
6. Upon termination of the membership, the data will be processed in accordance with the law. Retention periods held for another ten years and then deleted. In the period between the termination of the membership and the deletion, the processing of the data is restricted. They are then stored only for the purpose of Vereinschronik in the club archive.
